Must include a Letter of Employment, in English, verifying yearly income on company letterhead.
3. Sponsoring agencies must attach an official agency letter explaining the details of the scholarship, including conditions, amounts of the award, and the number of years the award is renewable.
4. Please note: Photocopies are not acceptable, and documents cannot be dated more than 6 months prior to the date of application.
