The program works closely with area superintendents, principals, and school corporation administration to respond to needs addressed by these constituents during stakeholder sessions provided by the department. Teacher candidates are taught strategies for working with students with disabilities and English language learners as they apply to curriculum and assessment within their lessons. The program is guided by the INTASC standards and the Indiana REPA Educator Standards. Teacher candidates are required to align objectives with the Indiana Content Standards (includes College and Career Readiness) in assignments and lesson plans. In addition to coursework and assignments, proficiency assessment is determined through the Teacher Work Sample (TWS) during the student teaching semester. Beginning in 2021-22, transition to teaching candidates enroll in EDUC 4215 Exceptional Learners. This one credit class will supplement existing coursework to better prepare candidates to teach students with disabilities in

the general education classroom.

Teacher candidates are taught strategies for working with students with disabilities as they apply to curriculum and assessment within their lessons. Strategies are introduced in the first course, EDUC 4200 Teaching as a Profession, and applied throughout subsequent coursework. Elementary candidates enroll in three courses emphasizing differentiated curriculum and instruction (Differentiated Curriculum and Instruction: Mathematics, Differentiated Curriculum and Instruction: STEM, Differentiated Curriculum and Instruction: Social Studies). Transition to teaching candidates also complete EDUC 4215 Exceptional Learners. This one credit course supplements other coursework to better prepare candidates to teach students with disabilities in the general education classroom.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Teacher candidates have extensive discussions and readings concerning special education and the general education teacher's responsibilities in special services, compliance with IEPs, and participating in case conferences.
